<p>Violation #15. Food separated &amp; protected; Single-use gloves RAW ANIMAL PRODUCTS MUST BE PROPERLY SEPARATED FROM READY TO EAT FOODS TO PREVENT CROSS CONTAMINATION. OBSERVED CRACKED EGG SHELLS AND RAW EGGS BEING STORED ABOVE READY TO EAT FOOD INSIDE REACH IN COOLER. PERSON IN CHARGE DISCARDED EGG SHELLS AND PLACE RAW EGGS ON BOTTOM LEVEL. (CORRECTED ON SITE). CODE REFERENCE: 64E-11.003(2). Foods shall be stored and handled to prevent cross-contamination. Raw animal foods shall be separated from RTE food and from other raw animal food during storage, preparation, holding, and display. Single-use gloves shall be used for only one task and purpose and discarded when damage occurs or the task is interrupted.</p>
<p>Violation #43. In-use utensils: properly stored IN USE UTENSILS MUST BE PROPERLY STORED AT ALL TIMES. OBSERVED AT TIME OF INSPECTION SUGAR HANDLE SPOON IN DIRECT CONTACT WITH THE PRODUCT. PERSON IN CHARGE WASHED, RINSE AND SANITIZED SPOON AND PLACED ON TOP OF CONTAINER. (CORRECTED ON SITE). CODE REFERENCE: 64E-11.003(4). The establishment shall use an approved method for the storage of in-use utensils during pauses in food preparation or dispensing.</p>
<p>Violation #55. Facilities installed, maintained, &amp; clean CLOTHES WASHERS MUST BE MAINTAINED AND IN GOOD REPAIR. OBSERVED AT TIME OF INSPECTION CLOTHES WASHER WITH HEAVY ACCUMULATION OF RUST INSIDE LAUNDRY ROOM. CODE REFERENCE: 64E-11.003(5). Floors, walls, and ceilings shall be smooth, durable, easily cleanable, and non-absorbent. Exterior areas shall be kept cleaned.</p>
