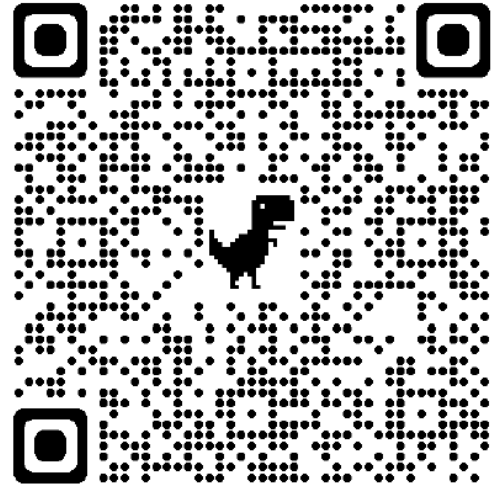
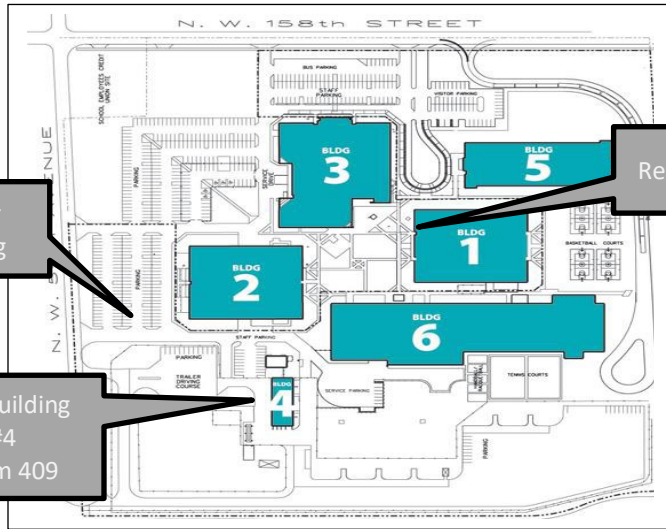


Scan for CDL Program Information

Registration Lottery List

1. Study for and complete Entry Level Driver Training.

You may use any method to complete the ELDT.

- Pass the test with 80% or better.
- Must bring a copy of completion certificate to be able to register for class.
- Must have results sent to the FMCSA.

2. Study for and complete the CDL Learner's Permit.

 - Study General Knowledge (Chapters 1, 2 and 3). * **Must be first test taken**
 - Study Air Brakes (Chapter 5).
 - Study Combinations (Chapter 6).
 - Go to DMV to take test.
 - Test may be broken down to one test, two tests, or all three tests taken at one time.
 - Permit will not be issued until **DOT Physical** test is completed.
 - Practice by using a test prep site or app (example CDL Genie or CDL Prep)

3. Drug Test

A "Pre-Employment" drug test is required for entry into the program. The drug test must meet the following requirements.

1. Drug test must be performed within **3 days** before the start of the program.
2. The test must be a "**Federal**" "**FMCSA**" drug test.
3. Drug test "receipt" must be submitted to the instructor on the first day of class. The "receipt" is the form given by the clinic upon submission of the test sample; **it is not the results.**
4. **You will be required to return to the clinic to retrieve your results and submit them to your instructor within 1 week from the beginning of the class.**

Failure to conduct the test as described above, the return of a "Failed" drug test, or failure to provide proof of completion of the drug test before the end of the second day of class; will result in the expulsions of the student from the program and loss of deposit.
